# Little Copper Club Award Programs

The Little Copper Club savings account is designed to encourage members under 18 years of age to begin their financial awareness experience by rewarding savings behaviours. BankVic has included the following awards for Little Copper Club account holders to participate in which are subject to the conditions outlined in this document:

1. Little Copper Club Savings Award
2. Little Copper Club Education Award

The Little Copper Club Savings & Education Awards are provided by Police Financial Services Limited ABN 33 087 651 661, AFSL 240293 (BankVic) of Level 8 505 Little Collins Street, Melbourne Vic 3000.

## Program Eligibility

- Members must be Victorian residents and under the age of 18 years to be eligible to be considered for the awards.
- Children of BankVic employees and directors are not eligible to receive these awards.

# Little Copper Club Education Award

## Conditions of Entry

1. The Education Award is open to eligible members who have a minimum of \$250 in their Little Copper Club (S3) account at 12:00am AEST on the last day of June each year.
2. The award will be determined at 11.00am on the second Monday of July each year at the Head Office of BankVic, Level 8 505 Little Collins Street, Melbourne Vic 3000. The awardee will be notified via the email address registered on their account and their first and last name will be published in our quarterly Member Matters which can be found on our website.
3. The person receiving the Education Award will receive \$1,000 which will be deposited via electronic transfer into their Little Copper Club account by the third Monday of July in the year they are awarded.
4. The \$1,000 Education Award is not transferable as traveller's cheques, foreign currency or as a deposit to a non BankVic account.
5. BankVic's decision in relation to any aspect of the award will be final and binding and no correspondence will be entered into.
6. BankVic is not liable and is released by each entrant from any claim or liability in relation to participation in this award.
7. Personal information will be used by BankVic only to check the winner meets the conditions of entry, and as per relevant legislation affecting the conduct of lotteries will be retained for three years following the draw and then destroyed.



# Little Copper Club Savings Award

## Conditions of Entry

1. The Savings Award is open to eligible members who have a minimum balance of \$100 in their Little Copper Club (S3) account at 5.00pm on the last day of November each year.
2. Eligible members may be chosen to receive a maximum of one award from eleven available awards with the amount of each award based on the balance in the member's Little Copper Club account according to this table:
